2. From the Principal Secretary / Commissioner of Labour, Chennai – 600 006, Letter No.Z1/1391/2021, dated 14.08.2021 and 15.12.2021.

ORDER:

The Minimum Wages State Advisory Board was last reconstituted in the Government Order first read above. The term of the non-official members of the above board had already expired.

2) The Principal Secretary / Commissioner of Labour in the letters second read above, has sent proposal for reconstituting the Board suggesting the names of employees' and employers' representatives and independent members to be appointed to the Board.

3) After careful consideration of the proposal of the Principal Secretary / Commissioner of Labour, the Government have decided to reconstitute the Minimum Wages State Advisory Board and accordingly issue orders as appended to this order.

4) The appended Notification will, accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. The Director, Tamil Development and Information (Translation) Department, Secretariat, Chennai - 600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai - 600 001. The Works Manager, Government Central Press, Chennai - 600 001 is requested to publish the Notification in the Tamil Nadu Government Gazette and send five copies of the Gazette to the Government and to the Commissioner of Labour, Chennai - 600 006 for reference and record.

5) The term of office of the non-official members shall be two years commencing from the date of their nomination. But the non-official members shall continue to hold office until their successors are nominated.

6) The Board will be treated as a First Class Committee for the purpose of Travelling Allowance / Daily Allowance. The Joint Commissioner of Labour (Minimum Wages), is authorised to countersign the Travelling Allowance / Daily Allowance Bills of the Non - Official Members of the Board and the Administrative Officer (Minimum Wages) in the Office of the Commissioner of Labour, Chennai - 600 006 is authorised to draw and disburse the amount to the non-official members as per G.O.(Ms) No.551, Finance (Allowances) Department, dated 03.11.2004 and G.O.(Ms) No.28, Finance (Allowances) Department, dated 29.01.2008

7) The expenditure on account of the Travelling Allowance and Daily Allowance shall be debited to:

“2230-01 Labour and Employment – 001. Direction and Administration-I Non-Plan-AA. Headquarters Staff Commissioner of Labour 04.Travel Expenses - 01. Tour Travelling Allowance”


